

- 2. The firm has to supply its PAN No. for deduction of taxes (If any applicable).
- 3. The rates of the items must be quoted with all the terms & conditions and must be for KVK, S.A.S. Nagar destination basis. The rates will be valid for the month of January & February, 2026.
- 4. Incomplete quotations or received after due date/time shall be rejected forthwith. KVK does not take any responsibility for any postal delay in delivery by Registered/ Speed Post or lost in transit of the quotation.
- 5. Conditional and unsigned quotation will not be accepted.
- 6. Delivery period of the items must also be intimated clearly in the quotations, no further correspondence in this regard will be communicated by the KVK.
- 7. The quotation shall not contain corrections, erasers and overwriting, it will result in rejection of quotation straightway.
- 8. The KVK reserves all the rights to accept or reject any/all quotation (s) and to increase or decreases quantity or configuration of items specified without specifying any reason. No correspondence will be made on this matter.
- 9. Above mentioned Quantities are tentative and can be increased/ decreased to any extent or can be totally omitted according to sanctioned amount & the firm will have no claim on this account.
- 10. If the date of opening of quotations is declared as Public Holiday then the quotations will be opened on the next working day at the same time. The terms & conditions will remain the same.
