5. Conditional and unsigned quotation will not be accepted.
6. Delivery period of the items must also be intimated clearly in the quotations, no further correspondence in this regard will be communicated by the KVK.
7. The quotation shall not contain corrections, erasers and overwriting, it will result in rejection of quotation straightway.
